



LIMITED LIFETIME NON-PRORATED TRANSFERABLE WARRANTY

Covering materials of original purchase and subsequent owner if transferred.

LIMITED LIFETIME WARRANTY

Royal Sierra warrants to the original consumer purchaser only that its vinyl (polyvinyl chloride) fencing, railing and profiles are free of defects in workmanship and material and that, in the course of normal and proper use, its vinyl products will not warp, corrode, rot, rust, peel, be damaged by pests or have abnormal weathering discoloration. This warranty is applicable for non-commercial applications for as long as the original purchaser owns the product. The limited warranty may be transferred by the original owner to any subsequent owner of its property, provided Royal Sierra receives a written request of transfer, proof of the original purchase, and \$100 transfer fee payable to Royal Sierra Products within thirty (30) days from the date of the real estate title transfer. Failure to request to transfer the warranty to the new owner and pay the specified transfer fee will relieve Royal Sierra of any further obligation under this warranty. 20-YEAR LIMITED WARRANTY-COMMERCIAL APPLICATIONS

For commercial and governmental applications, this warranty is applicable for a period of twenty (20) years from the date of purchase. This twenty (20) year warranty extends only to the original business or government agency purchaser, and is not transferable to any subsequent business or government agency purchaser.

SIERRA PRODUCTS WARRANTIES DO NOT COVER

- Any materials not manufactured or supplied by Royal Sierra or one of its facilities. (Materials may be covered by original manufacturers' warranties.)
- Damage caused by improper installation, failure to comply with Sierra Profiles installation procedures or improper applications.
- Damage caused by fire, earthquakes, violent storms, or any other weather disturbance.
- Damage due to exposure to pollutants, solvents, glues, paints, chemicals or other substances.
- Damage (including discoloration) due to misuse, abuse, impact of objects, breakage; alteration of the product by applying heat or welding; any physical material alteration.
- Failure of or damages to walls, surfaces or structures to which Products are applied arising from settlement, movement, or cracking thereof.
- Distortion or warping due to unusual heat sources (including outdoor grills and reflection from windows or foil sheathing).
- Installation costs, removal costs, hardware costs, labor and other related costs.
- Any consequential or incidental damages.
- Product which experiences color change due to normal weathering is excluded from this warranty.

REGISTRATION

Original consumer purchaser must complete the Warranty Registration Card and return within ten (10) days of purchase.

CLAIMS

Contact the dealer who sold or installed the fence or deck materials or write: Royal Crown Limited, P.O. Box 360, Milford, IN 46542. This must be done within thirty (30) days upon discovery of any claimed defects. Royal Sierra shall be entitled to require delivery of vinyl samples to determine validity of claim. Proof of purchase must also be provided. Questions may be directed to Royal Sierra toll-free at 800-365-3625.

OTHER CONSIDERATIONS

The obligations of Royal Sierra under this warranty are at its option either to refund the price (if already paid) attributable to the faulty materials or repair, rectify or replace the faulty materials (provided that the purchaser has provided safe access to such materials to Royal Sierra or its agent). Royal Sierra reserves the right to discontinue or change any of its products without giving notice to the original purchaser or subsequent owner. In the event of such discontinuance or change, Royal Sierra shall not be liable to the original purchaser or subsequent owner. Should a product covered by this warranty be unavailable, Royal Sierra reserves the right to substitute a product that is of equal quality or price according to Royal Sierra's sole discretion.

Royal Sierra and its representatives are not qualified to approve, recommend or advise as to the suitability of its products for possible applications. Your local building code authority and fire marshal's office should be consulted as to the proper and safe use of the products including the installation of structures with specific load-bearing capacities or other zoning code requirements.

THIS WARRANTY IS GIVEN IN LIEU OF ALL OTHER WARRANTIES, LIABILITIES OR OBLIGATIONS OF ROYAL SIERRA, EITHER EXPRESSED OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. ROYAL SIERRA SHALL IN NO EVENT BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL OR SPECIAL DAMAGES OF ANY KIND FOR BREACH OF ANY EXPRESS, WRITTEN OR ORAL OR IMPLIED WARRANTY ON PRODUCTS. YOUR EXCLUSIVE REMEDY SHALL BE ENFORCEMENT OF THIS WARRANTY UPON THE TERMS AND CONDITIONS HEREIN CONTAINED. NO REPRESENTATIVE OF ROYAL SIERRA OR ITS DISTRIBUTORS OR DEALERS IS AUTHORIZED TO MAKE ANY CHANGE OR MODIFICATION TO THIS WARRANTY.
